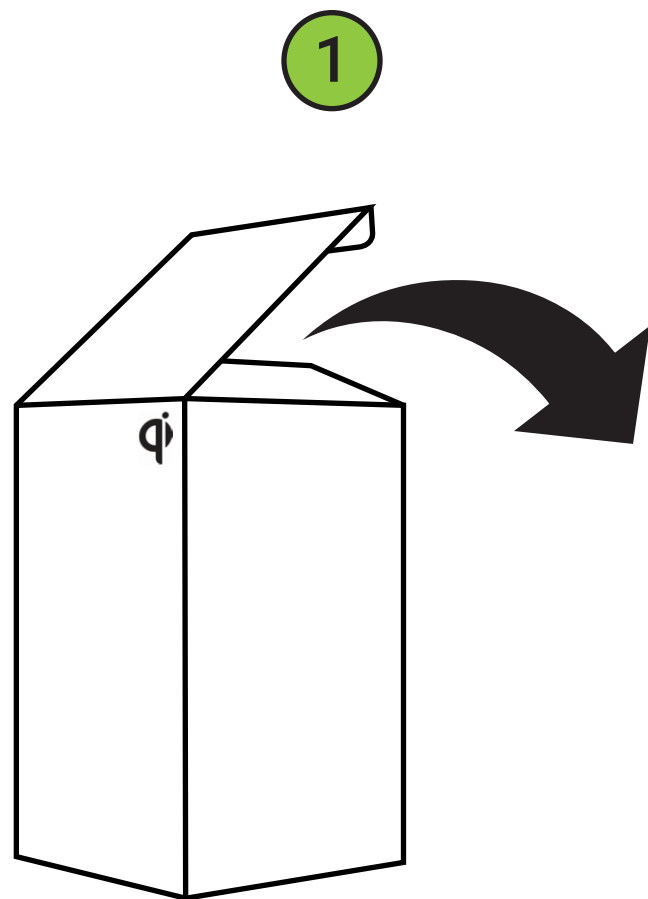




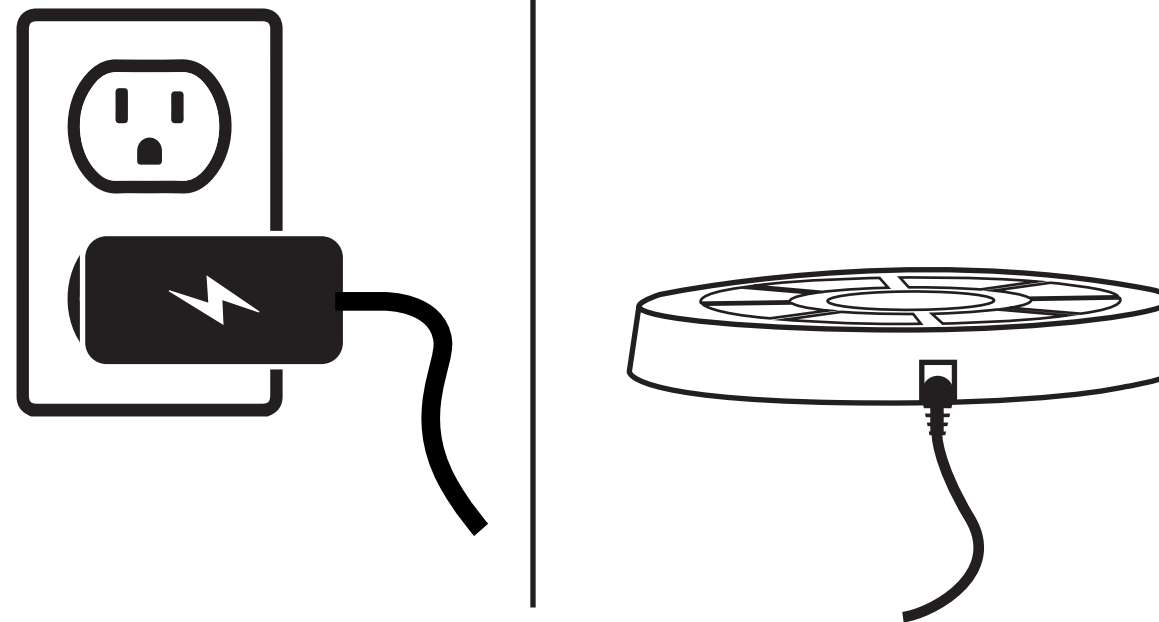

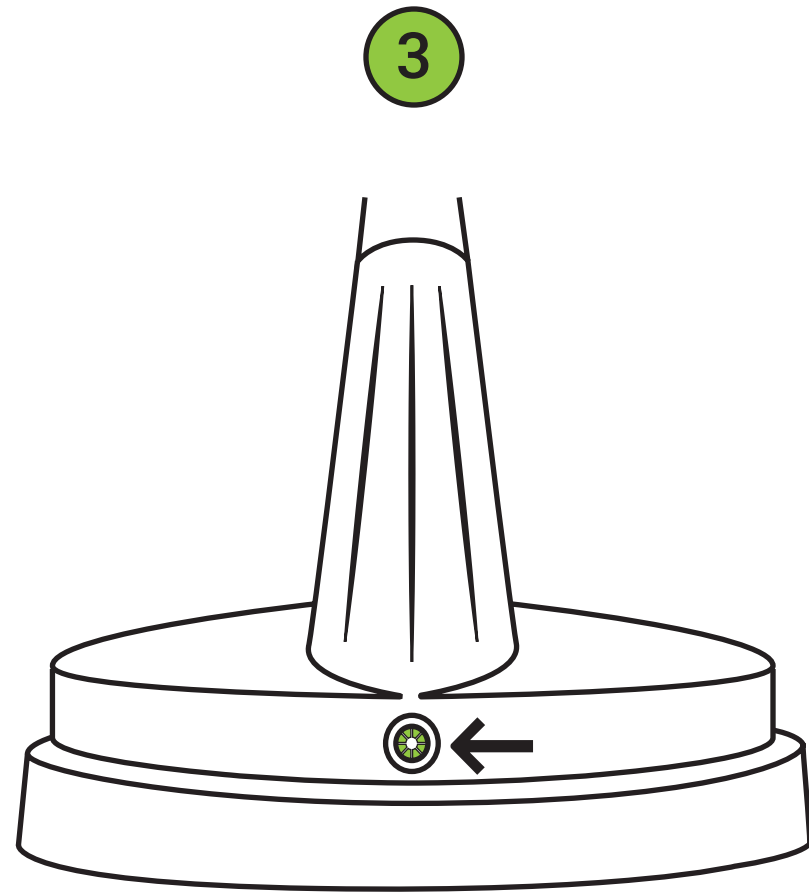


Remove lamp and accessories from all packaging.

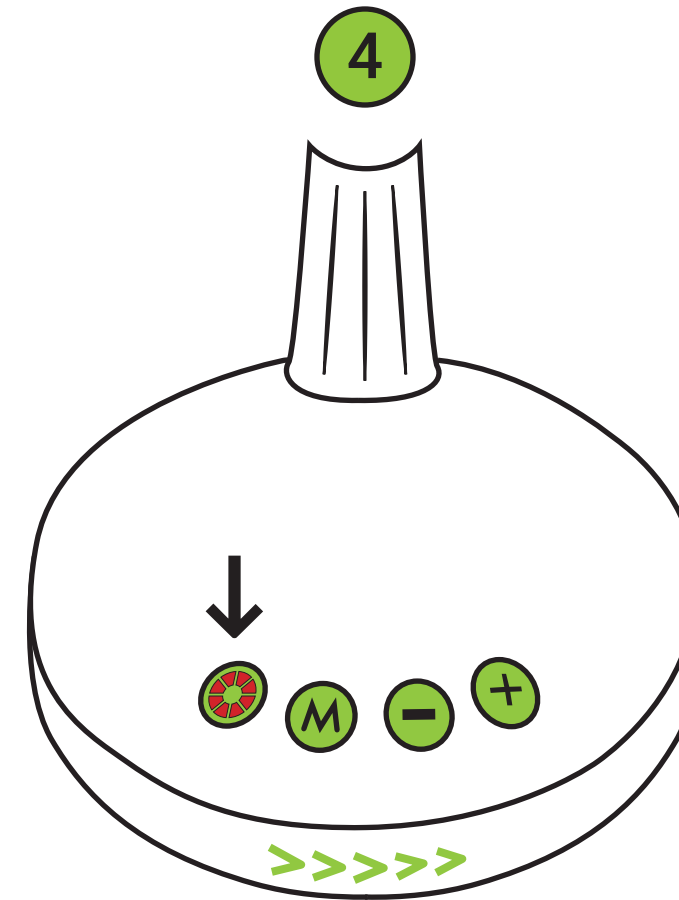


Plug adapter into wall outlet and wireless charging pad.



Place lamp on charging pad and press the master power button on the back of the lamp. Button will illuminate green when switched 'on.'

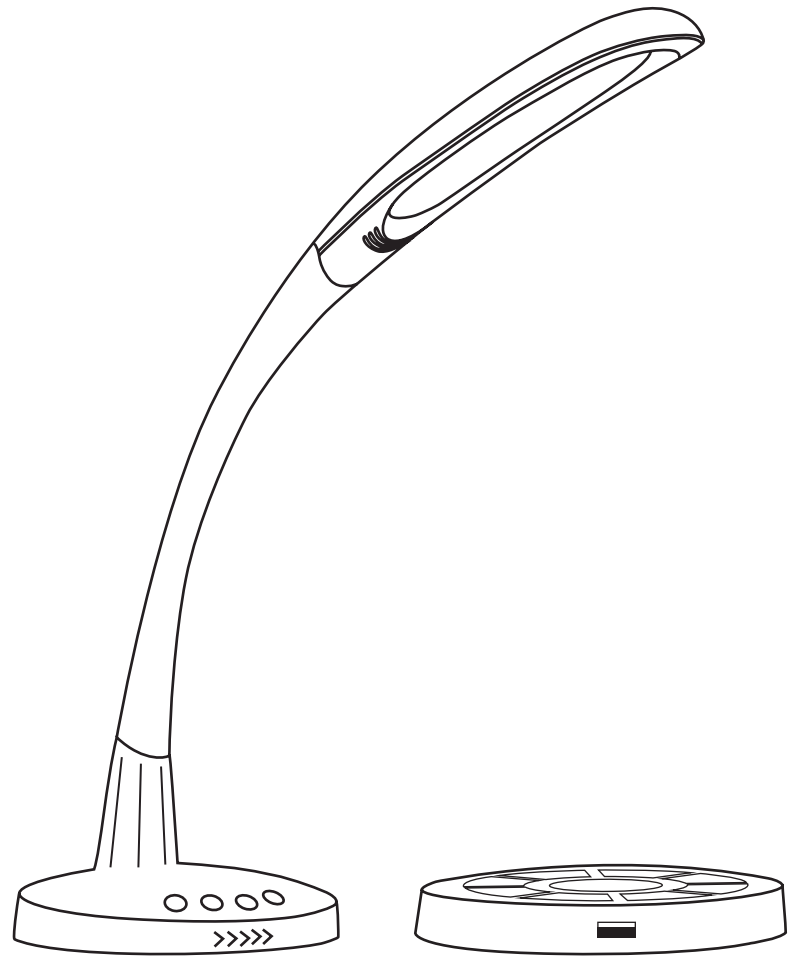
NOTE: Lamp will flash on/off once as a systems check.



Touch On/Off button  and adjust to desired settings.

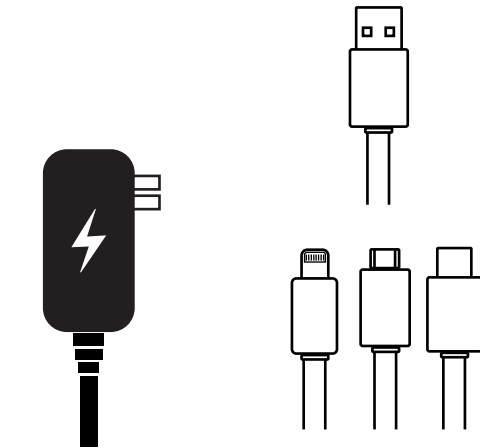

SYMBOL	FUNCTION	HOW TO OPERATE
	ON / OFF	Touch on/off button to power LEDs on or off. Your light has memory and will remember your previous settings.
	MODE	Touch to cycle through color spectrums of light. Hold when light is off to turn off button back-light.
	INCREASE BRIGHTNESS	Touch to increase light brightness between 10 different settings.
	DECREASE BRIGHTNESS	Touch to decrease light brightness between 10 different settings.
	CHARGING INDICATOR	Arrows will illuminate to denote how much charge the lamp has. All green means full charge. Your light should come out of the box about 40% charged.

Qi Certified: Assuring a safe and reliable wireless charging experience.



WARRANTY INFO

All Stella product warranties are for 2 years from date of purchase unless otherwise stated. This warranty applies to new products purchases from Stella Lighting or Stella Lighting authorized retailer.

Stella Warranties cover the following failure types:

1. Failure to function as advertised under normal operating condition
2. LED performance more than 35% below advertised lumen output
3. Flickering LED's or failure of individual LEDs.

The warranty excludes the following:

1. Failure due to improper handling or operation on the part of the buyer including the use of an unstable power source.
2. Products dismantled or modified without written approval from Stella Lighting or products used in conjunction with parts not provided by Stella Lighting, including but not limited to power cords or power adapter not provided by Stella Lighting.
3. Products operated or stored in ambient temperatures outside the approved range of -25C to 45C.
4. Products repaired or altered by persons not authorized by Stella Lighting.
5. Acts of God or other Force Majeure.
6. Remote battery failure or failure of any other replaceable consumable parts.

Verification of Failure

1. Warranty coverage is subject to verification of the failure by Stella Lighting.
2. Verification must be performed at a Stella Lighting warehouse location.

Stella Lighting Liability under the Limited Warranty

If failure occurs within 30 days of purchase date, Stella Lighting will pay for shipment of the product to the Stella Lighting warehouse for verification. For failures outside of 30 days from date of purchase the buyer is responsible for shipment of the product to the Stella Lighting warehouse for verification and will need to provide proof of delivery if requested. When verification has taken place Stella Lighting will provide coverage for the product. In cases where the product can be repaired and returned to the buyer in good working condition, Stella Lighting will repair and return the product. In cases where the product cannot be restored to reasonable working condition Stella Lighting will provide the buyer with a new product of the same model or closest equivalent if that model is no longer available. In all cases of repair or replacement covered under warranty Stella will cover return shipment of the product to the buyer.

Repair of product not covered under warranty.

In order to ensure lifetime viability of the product, Stella Lighting provides low cost repair services for products outside of warranty coverage. For non warranty repairs, the buyer is responsible for shipping the failed product to Stella Lighting for evaluation. If there is no issue with the lamp as it was sent back because of user error, the user will need to pay the \$75 repair fee before it leaves the Stella



warehouse. If after evaluation there is an issue with the lamp, Stella will offer to fix the lamp back to fully functioning capacity for \$75 including shipping. If the lamp cannot be fixed, Stella will provide a \$75 discount towards the purchase of a replacement lamp.

Refurbished Product Warranty

Stella products purchased directly from the Stella Outlet Store or marked as “refurbished” are covered under the Refurbished Product Warranty. Refurbished products are covered for 2 years from date of purchase. Refurbished products must be registered to receive warranty coverage as described in section 1. For refurbished product, the buyer is always required to ship the product to a Stella Lighting for verification before warranty coverage will be provided. When verification has taken place Stella Lighting will provide coverage for the product. In cases where the product can be repaired and returned to the buyer in good working condition, Stella Lighting will repair and return the product. In cases where the product cannot be restored to reasonable working condition Stella Lighting will provide the buyer with another refurbished product of the same model or closest equivalent if a refurbished version of that model is not available. In all cases of repair or replacement covered under Refurbished Product Warranty, Stella will cover return shipment of the product to the buyer. For failures not covered under warranty, refurbished product buyers can take advantage of the same low cost repair options as new product purchasers as described in section 7.

HOW DOES YOUR STELLA»GO RECHARGE?

The Wireless Power Consortium (WPC) is an open standards development organization dedicated to creating safe, efficient and compatible products regardless of the manufacturer or brand. The 200+ members of the WPC include Apple, Dell, IKEA, HTC, Lenevo, LG, Panasonic, Samsung, Sony, Verizon and of course, Stella Lighting.

Qi charging and your new Stella»GO

1. What is WPC's Qi certified program, and why is it such a priority?

Qi certified addresses the challenge of low quality, counterfeit products that are potentially unsafe with a certification program for wireless charging products built to the Qi standard.

The Wireless Power Consortium (WPC) operates a certification program based on the global wireless charging standard, Qi, (pronounced "Chee"). The WPC tests specific properties for safety, interoperability, and usability each of which can involve multiple test procedures:

- Transmitters (Qi wireless chargers) - 17 properties tested
- Receivers (Qi enabled smartphones or cases/covers) - 10 properties tested

2. What are the main benefits of Qi certified?

Qi certified wireless chargers are sophisticated products that are safe, efficient and easy to use. Millions of wireless charging products based on Qi are used safely every day. The tests for Qi certification verify the

product uses all mandatory safety features, as well as features that are necessary to ensure compliance to the Qi standard, energy efficiency, and compatibility of wireless power transmitters and power receivers.

3. How do I know if a product is Qi certified?

The simplest method is to look for the Qi logo on the product or on the packaging of the product. Only Qi certified products can legally use the Qi logo, but imitation or counterfeit charging products may use the Qi logo illegally. So, how can you be assured that a product is really Qi certified?

There are two easy ways to find out:

- WPC issues an official Qi Certificate of Registration that manufacturers can provide to retailers or other companies demanding proof.
- Search the product on the WPC's Qi Certified Product Database.

4. What needs to happen in order for products to be listed in this database?

Products may be included in the Qi Certified Product Database under these conditions:

- The product has passed compliance testing by an authorized test lab (ATL)
- The product has passed interoperability testing by an Interoperability Testing Center (IOC)
- The product is compliant with the latest version of the Qi Specification
- The owner of the product is a Qi Logo Licensee.

5. Can uncertified products use the Qi logo?

Although not required, only Qi certified products can legally use the Qi logo, but imitation or counterfeit charging products may use the Qi logo illegally.

Click [here](#) to see the current list of Qi certified products. Manufacturers are advised to print the Qi logo on all product packaging, as it's a clear sign the product has passed all tests necessary for Qi certification. A lack of a Qi logo on packaging could indicate that the wireless charging product is uncertified.

6. If a consumer is shopping for a wireless charging product or accessory, how would they check to see what products are Qi Certified?

Consumers can look for the Qi logo on the product's packaging. That is a simple but not 100% reliable method. The alternative is to look up the



product in the WPC search page to find Qi Certified products.

7. Is there a place on the WPC web site where consumers could find a retail outlet to purchase these products?

No, but most Qi Certified products can be found at large national retailers and online sites. Just be sure to double check the registered products page.

8. What does it mean when companies refer to their products as Qi compatible or Qi compliant? Does it mean the product is certified?

When companies use these terms, this is by no means a guarantee their products are certified. Be cautious of claims of “Qi compliant,” “Qi compatible,” “Qi enabled” or “works with Qi,” as these may indicate a product has not undergone Qi certification testing. The way to ensure a product is Qi certified is to search the product on the WPC’s Qi Certified Product Database.

9. What are the main risks with fake (uncertified) wireless charging products?

Imitation or fake products pose serious risks, including safety risks due to

overheating, risk of device damage and risk of incompatibility.

- Safety due to overheating: Testing conducted in independent labs found non-certified product temperatures reaching nearly 200°F, a temperature that could cause injury, such as 3rd degree skin burns.

- Device damage risks: Overheating drains and shortens battery life. Temperatures above 200°F can melt phone cases and potentially damage surfaces in contact with a non-certified charger or a non-certified smartphone cover or case.

- Incompatibility: Non-certified products may be incompatible with other wireless charging products.

11. What if a consumer buys a new smartphone with Qi integrated in the device, will it work with earlier version Qi charger products?

Yes. All Qi Certified products are backwards compatible, independent of the version.

13. How does a manufacturer get a product certified?

Products become Qi certified under these conditions:

1. The product has passed compliance testing by an authorized test lab

(ATL)

2. The product has passed interoperability testing by an Interoperability Testing Center (IOC)
3. The product is compliant with the latest version of the Qi Specification
4. The owner of the product is a Qi Logo Licensee.

14. Is Qi certification a guarantee of product safety?

Products must comply with many product safety regulations. Qi certification covers a small subset of product safety features. Product manufacturers are responsible for ensuring that their products meet any applicable product safety regulations. A Certification by the Wireless Power Consortium does not guarantee product safety.
